### **MINIMUM EDUCATIONAL QUALIFICATIONS**

#### Technician (Diploma) Apprentices:

➤ Diploma in Engineering / Technology in full time granted by a State Council or Board of Technical education Established by a State Government/University/Institutions in relevant discipline

### **Graduate (Degree) Apprentices:**

➤ Full time graduate degree granted by a recognized university / Institutions in relevant discipline.

### OTHER ELIGIBILITY REQUIREMENTS:

- 1. Diploma / Graduate candidates who have passed the qualifying exam in 2022 / 2023 / 2024 are only eligible.
- 2. Candidates who have registered themselves in the Apprenticeship Portal for Apprenticeship and who fulfill the eligibility criteria as indicated above will be considered for appearing in the walk-in interview.
- 3. Candidates should not have undergone or presently undergoing Apprenticeship Training elsewhere.
- 4. Candidates should not have experience of one year or more in any job.
- 5. The Degree or Diploma should have been obtained from a Board / University. Certificates issued by private bodies will not be considered.

### AGE:

Technician / Diploma: Minimum 18 years and maximum 24 years for Technician/Diploma Apprentices as on date of interview.

Graduate/Degree: Minimum 21 years and maximum 26 years for Graduate/Degree Apprentices as on date of interview.

**Relaxation**: (Relaxation by 5 years for SC/ST, 3 years for OBC). Candidates belonging to PWD Categories shall be given age relaxation upto 10 years (upto 15 years for SC/ST and upto 13 years for OBC (Non-Creamy Layer) Candidates.

#### **RESERVATION OF VACANCIES:**

Reservation for SC/ST/OBC(Non Creamy Layer)/PWD will be applicable as per the provisions of Apprentice Act. Those claiming reservation under SC/ST/OBC (NCL)/ PWD shall provide certificate as per Government Standard format, failing which their claim for reservation will be considered as 'General' category only. Candidates claiming reservation under OBC (NCL) category should also submit OBC (NCL) certificate as per the approved (OBC-NCL) format from the certificate issuing authority.

#### **APPRENTICESHIP REGISTRATION:**

- d. Upload Resume
- e. Choose Establishment name
- f. Type "NATIONAL INSTITUTE OF OCEAN TECHNOLOGY" and search
- g. Click apply
- h. Click apply again

- All Certificates/Testimonials in respect of Qualifications, Date of Birth, etc.
- Caste Certificate [for SC/ST/OBC(NCL)/EWS candidates as applicable] in the prescribed format issued by the Competent Authority as prescribed by Government of India.
- Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above at the time of walk-in-interview, their candidature will not be considered.

- 2. Candidates have to submit their duly filled-in application available in NIOT Website along with original and self-attested copies of certificates, mark sheets, proof of date of birth (copy of SSLC/HSC), Aadhaar Card, a passport size color photograph at the time of interview.
- 3. Candidates should have their valid Aadhaar Number.
- 4. The original documents including educational qualification, Birth / SSLC certificate, community and experience certificate, etc., will be verified at the time of walk-in-interview. Your joining at NIOT as apprenticeship trainee is subject to verification of certificates.
- 5. If number of candidates are more, the Selection Committee shall adopt its own criteria and shortlist the candidates for walk-in- interview in proportionate to the available vacancies.
- 6. Successful apprenticeship trainees will be awarded National Apprenticeship Certificate by Board of Apprenticeship Training (BOAT).
