SHIPPING OF THE SUBMERSIBLE HDPE FISH CAGE SYSTEM COMPONENTS FROM NIOT TO PORT BLAIR

1. SCOPE OF WORK

A. Inspection & Verification

- Conduct an inspection of all components prior to packing.
- Verify quantity, weight (~6500 kg), and volume (~55 m³) of material to be shipped.

B. Packing & Protection

 Professionally pack all components to ensure protection from mechanical damage, rough handling during transport

C. Loading

- Load materials into appropriate containers (FCL 20 feet) as per ISO standards.
- Any gaps between components or between the cargo and container walls must be filled with appropriate void-fill materials (e.g., wooden pallets, airbags, foam pads) to restrict cargo movement.
- Once loading is complete and verified, seal the container.

D. Transportation to Port

- Transport the packed cargo from NIOT, Chennai, to the Chennai Port.
- Handle all documentation for port entry, customs clearance etc.

E. Sea Freight Shipping

- Ensure the timeline aligns with project deployment schedule and avoids monsoon or delay risks.
- Provide cargo insurance coverage for the shipment.

F. Port Handling at Port Blair

 Coordinate with Port Blair authorities for customs clearance (if required), unloading, and

container delivery.

G. Final delivery & Unloading

- Transport the containers from Port Blair Port to the ACOSTI Sri Vijaya Puram, Andaman & Nicobar Islands.
- Carefully unload the components at the designated location.
- Ensure no component damage or loss during final delivery.
